Chou Associates Management Inc. ("the Manager") manages the overall business of the Fund, including the selection of the securities in the Fund's portfolio and promoting sales of the Fund's units. For the purposes of this document, the terms Chou Associates Management Inc. and "the Manager" are interchangeable. Full contact information for the Manager is located at the end of this report.

Management Discussion of Fund Performance

Investment Objective and Strategies

Chou Asia Fund's (the "Fund") objective is to provide long-term growth of capital by investing primarily in the securities markets of Asia considered by Chou Associates Management Inc. (the "Manager") to be undervalued. The Fund may also invest in securities other than equities and in businesses located outside of Asia. The Fund's investments may also include common and preferred shares, convertible debentures, options, warrants, government and corporate bonds and short-term indebtedness. The Fund may also use derivatives such as, but not limited to, futures, options, swaps and forward contracts to gain exposure to securities and asset classes consistent with the objectives of the Fund, and to hedge portfolio exposure against losses from foreign currency and domestic currency exposure and changes in securities prices.

The Fund's investment strategy follows a strong discipline with regard to the prices paid to acquire portfolio investments. The level of investment in a particular entity's securities is generally commensurate with the current price of the company's securities in relation to the Manager's assessment of such entity's intrinsic value as determined by various factors. This approach is designed to provide an extra margin of safety, which in turn, serves to reduce the Fund's overall portfolio risk.

Risk

The risks of investing in the Fund are disclosed in the Fund's most recently filed Simplified Prospectus which can be found on the Fund's website at <u>www.choufunds.com</u> and SEDAR+ at <u>www.sedarplus.ca</u>.

During the year ended December 31, 2023, there were no material changes that affected the Fund's overall level of risk.

Market Review

In 2023, the market, as measured by the MSCI AC Asia Pacific Index, gained 11.96% in U.S. dollars. Central banks in Asia increased rates during the year but much less than their US and European counterparts. While economic growth in China and across the region remained solid, concerns over the state of the Chinese economy weighed on markets. Chinese and Hong Kong stocks were down by 10% for the year. In contrast, Japanese stocks, driven by reforms and acquisitions, were up 28%.

Results of Operations

For the year ended December 31, 2023, the Fund increased by 17.0% for Series A units and 17.6% for Series F units after fees and expenses, while the MSCI AC Asia Pacific Total Return Index increased by 9.3% in Canadian dollars. In U.S. dollars, the Fund was up 19.5% for Series A units and 20.2% for Series F units, while the MSCI AC Asia Pacific Total Return Index increased by 12.0%.

The major advancers in 2023 were the equity holdings of IDFC Limited and Shriram Finance Limited.

The largest decliners in the year were the equity holdings of Postal Savings Bank of China Co Limited, Alibaba Group Holding Limited and Tencent Holdings Limited.

The Canadian currency appreciated against the Hong Kong dollar, which negatively affected the Fund.

Portfolio Update

During the year, the Fund eliminated its holdings in Samsung Electronics Company Limited, Pyne Gould Corporation Limited, JD.com Inc. and Atlas Corporation. The Fund reduced its holdings in BYD Electronic (International) Company Limited.

The Fund had no covered call options in its portfolio as at December 31, 2023.

The Fund received \$213 in income from its securities lending program in 2023.

The Fund did not enter into any foreign currency contracts in 2023.

The Fund's net redemptions for the year ended December 31, 2023 were approximately \$622,426 for Series A units and net redemptions of approximately \$1,229,633 for Series F units. Included in net redemptions are subscriptions, redemptions and transfers in/out. Out of the net redemptions for Series F units, \$113,405 was switched from Series A units following the OEO trailer ban. The Fund's average month-end cash position for the year was 32.8% of the Fund's net assets.

Recent Developments

The ongoing Russian invasion of Ukraine and COVID-19 pandemic have continued to disrupt businesses around the world, adding volatility to both domestic and international markets. While governments and central banks have maintained their support of the economy through monetary and fiscal policies, the health of the economy remains unclear at this time. Based on this increased uncertainty, we expect the performance of the Fund's portfolio to be affected to some degree in the near term.

Related Party Transactions

The Manager manages the overall business of the Fund, including selection of the securities in the Fund's portfolio, and promoting the sale of the Fund's units.

The Manager is also the trustee of the Fund. Investors receive units of a trust when they invest in the Fund. The Manager, as trustee, holds the actual title to the property in the Fund, the cash and portfolio securities, on behalf of the Fund's investors.

The Manager, its officers and directors invest in units of the Fund from time to time in the normal course of business. As of December 31, 2023, the Manager, its officers and directors do not hold any units of the Fund. All transactions with the Manager are carried out at the Fund's net asset value as at the transaction date.

During the year ended December 31, 2023, there were no transactions with related parties except in the capacities and instances set out above.

⁽⁵⁾ Management expense ratio ("MER") is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated year and is expressed as an annualized percentage of weekly average net asset value during the year. The Manager may, at its discretion, waive or absorb certain operating expenses. MER includes the waiver or absorption by the Manager of certain operating expenses, while the MER before absorption shows the MER prior to operating expenses being waived or absorbed by the Manager.

⁽⁶⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of weekly average net asset value during the year.

⁽⁷⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the financial year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Manager manages the Fund. The Manager is entitled to an investment management fee calculated daily as a percentage of the market value of the net assets equal to 1.5% per annum for Series A units and 1.0% per annum for Series F units, payable monthly. The Manager pays 50 basis points per year trailer fees to dealers out of management fees for Series A units. There is no trailer fee paid out for Series F units.


Past Performance


Year-by-Year Returns

Annual Compound Returns

The Index is based on the market capitalizations of approximately 900 leading companies publicly traded in the three developed market countries and eight emerging market countries in Asia. The benchmark Index is calculated without the deduction of management fees and fund expenses, whereas the performance of the Fund is calculated after deducting such fees and expenses.
