## Management Discussion of Fund Performance

### Investment Objective and Strategies

Chou Associates Fund's (the "Fund") objective is to provide long-term growth of capital by investing primarily in equity securities of United States ("U.S.") and foreign businesses considered by Chou Associates Management Inc. (the "Manager") to be undervalued. The Fund may also invest in the equity securities of Canadian businesses. The Fund's investments may include common and preferred shares, convertible debentures, options, warrants, government and corporate bonds and short-term indebtedness.

The Fund's investment strategy follows a strong discipline with regard to the prices paid to acquire portfolio investments. The level of investments in a particular entity's securities is generally commensurate with the current price of the company's securities in relation to the Manager's assessment of such entity's intrinsic value as determined by various factors. This approach is designed to provide an extra margin of safety, which in turn, serves to reduce the Fund's overall portfolio risk.

### Risk

The risks of investing in the Fund are disclosed in the Fund's most recently filed Simplified Prospectus which can be found on the Fund's website at [www.choufunds.com](http://www.choufunds.com) and SEDAR at [www.sedar.com](http://www.sedar.com).

During the first half of 2020, there were no material changes that affected the Fund's overall level of risk.

As at June 30, 2020, Fairfax Financial Holdings ("Fairfax") held 26.7% of the Series A units of the Fund. If Fairfax redeems its units, a significant portion of the Fund's investments may have to be liquidated in order to effect this transaction. The timing of such a liquidation may not be appropriate and all investors may suffer a proportionate loss as a result of such a liquidation.

Fairfax agreed in 2002 that it would not exercise any voting rights attached to units of the Fund or otherwise in any manner attempt to influence the affairs of the Chou Funds. This agreement remains in full force and effect and has been complied with by Fairfax to date.

### Market Review

The first six months of 2020 provided investors with a roller coaster ride. Markets in the United States hit new highs in mid-February, followed by substantial declines in late February/early March as the coronavirus pandemic emerged. Governments around the world attempted to stop the spread of the virus by imposing lockdowns and other restrictive measures. These actions had a dramatic impact on businesses and jobs, creating financial stress across the globe. Governments passed large fiscal measures in attempt to stabilize economies. Central banks, led by the Fed, provided markets with unprecedented amounts of liquidity to help stabilize markets. Late in the second quarter, the economy in the United States began to "open up" and the economy, jobs, and markets responded with a trend of recovery.

In general, the U.S. equity markets outperform that of other geographies. The technology sector did quite well during COVID-19, as individuals and firms relied more on information technologies for remote communication. Energy and financial sectors suffered on the other hand, as plummeting oil prices and general economy took a heavy hit.

### Results of Operations

For the period ended June 30, 2020, the Fund decreased 29.2% for Series A units and 29.0% for Series F units, after fees and expenses, while the S&P 500 Total Return Index returned 1.7% in Canadian dollars. In U.S.

dollars, the Fund decreased 32.3% for Series A units and 32.1% for Series F units, while the S&P 500 Total Return Index decreased 3.1%.

The largest decliners in the period were the equity holdings of Wells Fargo & Company, Resolute Forest Products, Bausch Health, Citigroup, and EXCO Resources. The increase in prices of DaVita shares and Overstock preferred shares helped to offset some of the losses.

The Canadian currency depreciated against the US dollar, which also positively affected the Fund.

### **Portfolio Update**

During the period, the Fund reduced its holdings in DaVita, Berkshire Hathaway, JPMorgan Chase, and Bausch Health. The Fund also received Overstock Series A-1 preferred shares as digital dividends.

The Fund did not make any new investments, or enter into any foreign currency contracts during the period ended June 30, 2020. The Fund also had no covered call options in its portfolio as at June 30, 2020.

In the first half of 2020, the Fund received \$4,871 in income from its securities lending program.

The Fund's net redemptions for the period ended June 30, 2020 were approximately \$13,905,926 for Series A units and approximately \$3,150,249 for Series F units. The Fund's average month-end cash position for the period was 4.5% of the Fund's net assets.

### **Recent Developments**

Since March 11, 2020, the outbreak of COVID-19 and related global responses have caused material disruptions to businesses around the world, leading to adverse impacts on domestic and international equity markets and fixed income yields.

While governments and central banks have reacted with monetary and fiscal interventions designed to stabilize economic conditions, the duration and extent of the impact of the COVID-19 pandemic, as well as the effectiveness of government and central bank responses, remains unclear at this time.

Based on this increased uncertainty, we expect the performance of the Fund's portfolio to be affected to some degree in the near term.

### **Related Party Transactions**

The Manager manages the overall business of the Fund, including selection of the securities in the Fund's portfolio and promoting the sale of the Fund's units.

The Manager is also the trustee of the Fund. Investors receive units of a trust when they invest in the Fund. The Manager, as trustee, holds actual title to the property in the Fund, the cash and portfolio securities, on behalf of the Fund's investors.

The Manager, its officers and directors invest in units of the Fund from time to time in the normal course of business. As of June 30, 2020, the Manager, its officers and directors hold 4.7% of the Series A units of the Fund. All transactions with the Manager are carried out at the Fund's net asset value as at the transaction date.

During the period ended June 30, 2020, there were no transactions with related parties except in the capacities and instances set out above.

The Manager may, at its discretion, waive or absorb certain operating expenses. MER includes the waiver or absorption by the Manager of certain operating expenses, while the MER before absorption shows the MER prior to operating expenses being waived or absorbed by the Manager.

<sup>(6)</sup> The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of weekly average net asset value during the period.

<sup>(7)</sup> The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the financial period. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

## Management Fees

The Manager manages the Fund. The Manager is entitled to an investment management fee calculated daily as a percentage of the market value of the net assets equal to 1.5% per annum for Series A units and 1.0% per annum for Series F units, payable monthly. The Manager pays 50 basis points per year trailer fees to dealers out of management fees for Series A units. There is no trailer fee paid out for Series F units.


### General

### Year-by-Year Returns



## Annual Compound Returns

The following tables<sup>(1)</sup> show the annual compound total return for each of the Series A and Series F units of the Fund. The tables outline the Fund's past performance for the one-, three-, five-, ten-, and fifteen-year periods ended on June 30, 2020 for Series A units and since inception and for the one-, three-, five- and ten-year periods ended on June 30, 2020 for Series F units. Also shown for the same periods are the respective historical annual compound total returns of the S&P 500 (the "Index"). The Index is based on the market capitalizations of 500 leading companies publicly traded in the U.S. stock market representing all major industries, as determined by Standard & Poor's. The Index is one of the most commonly followed equity indices and has been widely regarded as the best single gauge of the large cap U.S. equities market since the Index was first published in 1957. The benchmark Index is calculated without the deduction of management fees and fund expenses, whereas the performance of the Fund is calculated after deducting such fees and expenses.
