Chou Associates Management Inc. ("the Manager") manages the overall business of the Fund, including the selection of the securities in the Fund's portfolio and promoting sales of the Fund's units. For the purposes of this document, the terms Chou Associates Management Inc. and "the Manager" are interchangeable. Full contact information for the Manager is located at the end of this report.

Management Discussion of Fund Performance

Investment Objective and Strategies

Chou Europe Fund's (the "Fund") objective is to provide long-term growth of capital by investing primarily in the equity securities of European businesses considered by Chou Associates Management Inc. (the "Manager") to be undervalued. The Fund may also invest in securities other than equities and in businesses located outside of Europe. The Fund's investments may include common and preferred shares, convertible debentures, warrants, government and corporate bonds and short-term indebtedness.

The Fund's investment strategy follows a strong discipline with regard to the prices paid to acquire portfolio investments. The level of investments in a particular entity's securities is generally commensurate with the current price of the company's securities in relation to the Manager's assessment of such entity's intrinsic value as determined by various factors. This approach is designed to provide an extra margin of safety, which in turn, serves to reduce the Fund's overall portfolio risk.

Risk

The risks of investing in the Fund are disclosed in the Fund's most recently filed Simplified Prospectus which can be found on the Fund's website at www.sedar.com.

During the period ended June 30, 2019, there were no material changes that affected the Fund's overall level of risk.

Market Review

For the first half of 2019, European equities outperformed all other key asset classes despite continued concerns regarding trade tensions between the U.S. and China and its spillover effects to Europe.

Although political tensions in France eased materially since the start of the year when protests were at their height, other political challenges continued to weigh on European markets such as the resignation of UK Prime Minister Theresa May and the remaining uncertainty over Brexit negotiations.

On the fixed income side, the yield on 10-year German government bonds moved into negative territory during the second quarter for the first time since 2016 while European Central Bank President Mario Draghi hinted at further monetary policy easing if the inflation outlook fails to improve.

Results of Operations

For the period ended June 30, 2019, the Fund decreased 6.8% for Series A units and 6.6% for Series F units, after fees and expenses, while the MSCI AC Europe Total Return Index increased 12.0% in Canadian dollars. In U.S. dollars, the Fund decreased 2.9% for Series A units and 2.6% for Series F units, while the MSCI AC Europe Total Return Index increased 16.6%.

The major positive contributors to the Fund's performance in the first half of 2019 were the equity holdings of Eurobank Ergasias and Intralot.

The largest decliners in the same period were the equity holdings of Endo International, Teva Pharmaceutical Industries, and Ryanair Holdings. The Euro depreciated against the Canadian currency during the period, which also contributed negatively to the performance of the Fund.

The Fund initiated an equity position in CPL Resources PLC.

The Fund bought back call options of Endo International PLC expiring in January 2020 with a strike price of US\$15.00. The Fund did not write any new covered call options during the first half of 2019.

The Fund did not enter into any forward currency contracts for pounds sterling or Euros in 2019.

During the first half of 2019, the Fund received \$133 in income from its securities lending program.

The Fund's net redemptions in the first half of 2019 were approximately \$475,941 for Series A units and net purchases of approximately \$604,317 for Series F units. The Fund's average month-end cash position for the year was 26.5% of the Fund's net assets.

Recent Developments

There have been no recent market developments of particular note, aside from the normal fluctuations of the markets that are expected to have an undue influence on the portfolio of the Fund when compared to its benchmark.

Related Party Transactions

The Manager manages the overall business of the Fund, including selection of the securities in the Fund's portfolio, and promoting the sale of the Fund's units.

The Manager is also the trustee of the Fund. Investors receive units of a trust when they invest in the Fund. The Manager, as trustee, holds actual title to the property in the Fund, the cash and portfolio securities, on behalf of the Fund's investors.

The Manager, its officers and directors invest in units of the Fund from time to time in the normal course of business. As of June 30, 2019, the Manager, its officers and directors hold 1.2% of the Series A units of the Fund. All transactions with the Manager are carried out at the Fund's net asset value as at the transaction date.

During the period ended June 30, 2019, there were no transactions with related parties except in the capacities and instances set out above.

⁽⁵⁾ Management expense ratio ("MER") is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of weekly average net asset value during the period. The Manager may, at its discretion, waive or absorb certain operating expenses. MER includes the waiver or absorption by the Manager of certain operating expenses, while the MER before absorption shows the MER prior to operating expenses being waived or absorbed by the Manager.

⁽⁶⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of weekly average net asset value during the year.

⁽⁷⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the year. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Manager manages the Fund. The Manager is entitled to an investment management fee calculated daily as a percentage of the market value of the net assets equal to 1.5% per annum for Series A units and 1.0% per annum for Series F units, payable monthly. The Manager pays 50 basis points per year trailer fees to dealers out of management fees for Series A units. There is no trailer fee paid out for Series F units.

Past Performance


General


Year-by-Year Returns
