What does the fund invest in?

The Chou Bond Fund's investment objective is to provide conservation of principal and income production, along with capital appreciation. It invests primarily in Canadian and US fixed income securities. These fixed income securities include, but are not limited to Government of Canada, provincial, municipal and corporate issues, including convertibles and high yield fixed income securities, and fixed income securities outside of Canada and U.S. No more than 35% of the net assets of the fund, at the time of purchase, will be invested in fixed income securities outside of Canada and U.S.



How has the fund performed?

This section tells you how the Series F units of the fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the funds' returns.

Year-by-year returns

This chart shows how Series F units of the fund has performed in each of the past 10 completed calendar years. The fund dropped in value in 3 of the 10 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series F units of the fund in a 3-month period over the past 10 calendar years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

As of August 31, 2023, the annual compounded return of Series F units of the fund was 7.29% over the past 10 years. If you had invested \$1,000 in the fund 10 years ago, your investment would now be worth \$2,021.

I Don't buy this fund if you need a steady source of income from your investment. 	A word about tax In general, you'll have to pay income tax on any money you make on the fund. How much you pay depends on the tax laws where you live and whether or not you hold the fund in a registered plan, such as a Registered Retirement Savings Plan or a Tax-Free Savings Account. Keep in mind that if you hold this fund in a non-registered account, fund distributions are included in your taxable income, whether you get them in cash or have them reinvested.	

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series F units of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

Instead of paying a sales charge on each transaction, you pay an annual fee to your dealer based on the value of the assets. You pay no sales charge when you buy Series F units of the fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns. As of June 30, 2023, the fund's expenses were 1.60% of its value. This equals \$16.00 for every \$1,000 invested.
