Management Discussion of Fund Performance

Investment Objective and Strategies

Chou Asia Fund's (the "Fund") objective is to provide long-term growth of capital by investing primarily in the securities markets of Asia considered by Chou Associates Management Inc. (the "Manager") to be undervalued. The Fund may also invest in securities other than equities and in businesses located outside of Asia. The Fund's investments may also include common and preferred shares, convertible debentures, options, warrants, government and corporate bonds and short-term indebtedness.

The Fund's investment strategy follows a strong discipline with regard to the prices paid to acquire portfolio investments. The level of investment in a particular entity's securities is generally commensurate with the current price of the company's securities in relation to the Manager's assessment of such entity's intrinsic value as determined by various factors. This approach is designed to provide an extra margin of safety, which in turn, serves to reduce the Fund's overall portfolio risk.

Risk

The risks of investing in the Fund are disclosed in the Fund's most recently filed Simplified Prospectus which can be found on the Fund's website at www.choufunds.com and SEDAR at www.sedar.com.

During the period ended June 30, 2021, there were no material changes that affected the Fund's overall level of risk.

Market Review

For the first half of 2021, Asian equities performed positively with the MSCI AC Asia Pacific Index delivering a positive return of 4.0%. However, the performance of Asian equities lagged behind the performance of other global markets including the S&P 500 and Eurostoxx indices.

MSCI's China index performed positively with a return of 1.1% through the period. China's COVID-19 vaccination rollout gained momentum through 2021 and although the country's international borders remain shut, domestic air travel and tourism have rebounded. The Chinese markets were weighed down by regulatory concerns as Beijing stepped up regulatory scrutiny of e-commerce platforms like Alibaba, Baidu, and Tencent. Chinese tech stocks also came under further pressure after the U.S. Securities and Exchange Commission said it would begin to implement legislation to delist U.S.-listed Chinese companies that do not comply with U.S. audit requirements.

Many Asian countries faced a second wave of COVID-19 outbreaks and none more dramatically than India with new daily cases hitting a record level of 400,000, double the peak rate in the first wave. Renewed state lockdowns took effect though they were less severe and more targeted than initial rounds last year. The S&P BSE Sensex index performed positively with a return of 9.91%.

In other Asian economies, manufacturing and trading goods remained strong while consumption struggled to bounce back as the resurgence of COVID-19 outbreaks and lockdowns somewhat curbed investor optimism.

Results of Operations

For the period ended June 30, 2021, the Fund increased by 12.6% for Series A units and 12.8% for Series F units after fees and expenses, while the MSCI AC Asia Pacific Total Return Index increased by 2.1% in Canadian dollars. In U.S. dollars, the Fund was up 15.7% for Series A units and 15.8% for Series F units, while the MSCI AC Asia Pacific Total Return Index increased 5.1%.

The major advancers in the first half of 2021 were the equity holdings of IDFC Limited, Shriram Transport Finance Company Limited, and BYD Electronic (International) Company Limited.

The largest decliners in the same period were the equity holdings of Samsung Electronics Company Limited and China Yuchai International Limited.

The Canadian currency appreciated against the Hong Kong dollar, which also negatively affected the Fund.

Portfolio Update

During the period, the Fund reduced its holdings in BYD Company Limited.

The Fund did not make any new investments or enter into any foreign currency contracts during the period ended June 30, 2021. The Fund also had no covered call options in its portfolio as at June 30, 2021.

The Fund received \$9,633 in income from its securities lending program in the first half of 2021.

The Fund's net redemptions for the period ended June 30, 2021 were approximately \$662,350 for Series A units and approximately \$308,135 for Series F units. The Fund's average month-end cash position for the period was 6.1% of the Fund's net assets.

Recent Developments

The ongoing COVID-19 pandemic has continued to disrupt businesses around the world. Uneven vaccination rollouts and the emergence of new variants have added volatility to both domestic and international markets.

While governments and central banks have maintained their support of the economy through monetary and fiscal policies, the shape of the pandemic recovery remains unclear at this time.

Based on this increased uncertainty, we expect the performance of the Fund's portfolio to be affected to some degree in the near term.

Related Party Transactions

The Manager manages the overall business of the Fund, including selection of the securities in the Fund's portfolio, and promoting the sale of the Fund's units.

The Manager is also the trustee of the Fund. Investors receive units of a trust when they invest in the Fund. The Manager, as trustee, holds the actual title to the property in the Fund, the cash and portfolio securities, on behalf of the Fund's investors.

The Manager, its officers and directors invest in units of the Fund from time to time in the normal course of business. As of June 30, 2021, the Manager, its officers and directors do not hold any units of the Fund. All transactions with the Manager are carried out at the Fund's net asset value as at the transaction date.

During the period ended June 30, 2021, there were no transactions with related parties except in the capacities and instances set out above.

(2) Net assets and distributions are based on the actual number of redeemable units outstanding at the relevant time. The increase/decrease from operations is based on the weighted average number of redeemable units outstanding over the financial period.

(3) Distributions were reinvested in additional units of the Fund or paid in cash upon request.

(4) This information is provided as at the period end shown and is rounded to the nearest thousand.

(5) Management expense ratio ("MER") is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of weekly average net asset value during the period. The Manager may, at its discretion, waive or absorb certain operating expenses. MER includes the waiver or absorption by the Manager of certain operating expenses, while the MER before absorption shows the MER prior to operating expenses being waived or absorbed by the Manager.

(6) The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of weekly average net asset value during the period.

(7) The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the financial period. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Manager manages the Fund. The Manager is entitled to an investment management fee calculated daily as a percentage of the market value of the net assets equal to 1.5% per annum for Series A units and 1.0% per annum for Series F units, payable monthly. The Manager pays 50 basis points per year trailer fees to dealers out of management fees for Series A units. There is no trailer fee paid out for Series F units.

Past Performance

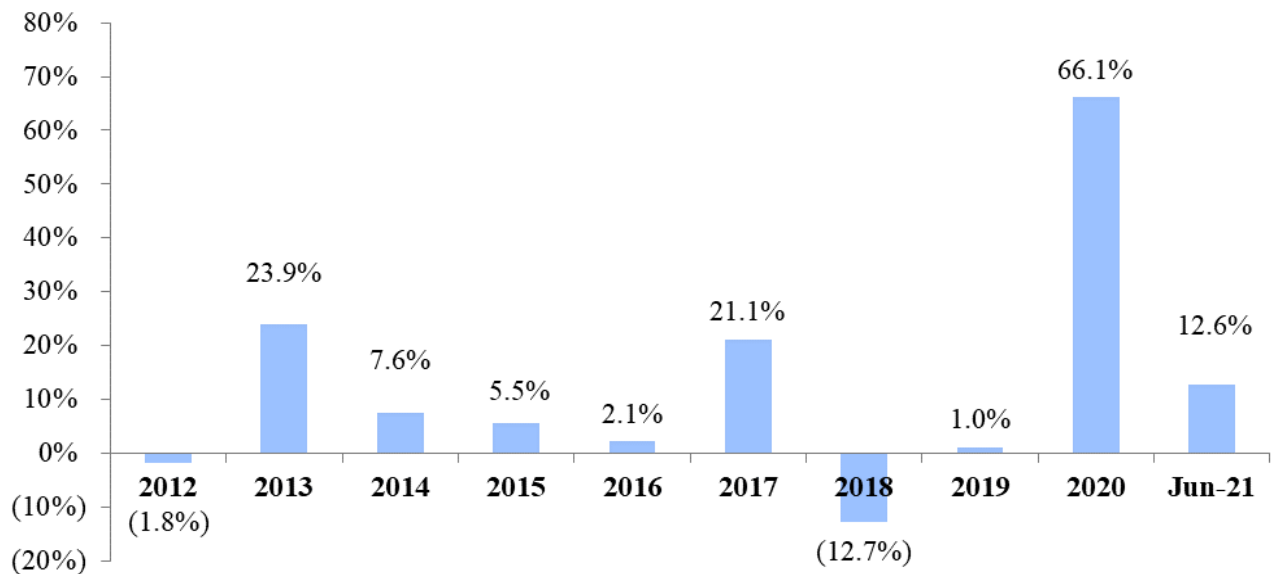
General

Year-by-Year Returns

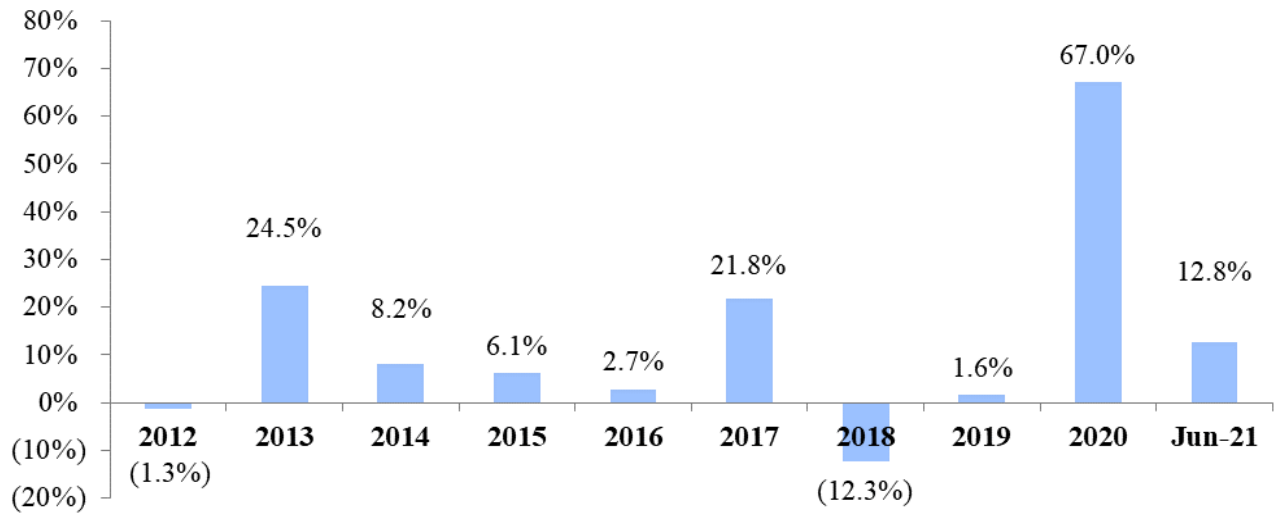

The benchmark Index is calculated without the deduction of management fees and fund expenses, whereas the performance of the Fund is calculated after deducting such fees and expenses.
