Management Discussion of Fund Performance

Investment Objective and Strategies

Chou Europe Fund's (the "Fund") objective is to provide long-term growth of capital by investing primarily in the equity securities of European businesses considered by Chou Associates Management Inc. (the "Manager") to be undervalued. The Fund may also invest in securities other than equities and in businesses located outside of Europe. The Fund's investments may include common and preferred shares, convertible debentures, options, warrants, government and corporate bonds and short-term indebtedness.

The Fund's investment strategy follows a strong discipline with regard to the prices paid to acquire portfolio investments. The level of investment in a particular entity's securities is generally commensurate with the current price of the company's securities in relation to the Manager's assessment of such entity's intrinsic value as determined by various factors. This approach is designed to provide an extra margin of safety, which in turn, serves to reduce the Fund's overall portfolio risk.

Risk

The risks of investing in the Fund are disclosed in the Fund's most recently filed Simplified Prospectus which can be found on the Fund's website at www.choufunds.com and SEDAR at www.sedar.com.

During the period ended June 30, 2021, there were no material changes that affected the Fund's overall level of risk.

Market Review

For the first six months of 2021, European equities performed positively. The Euro Stoxx index increased by 13.7%, the DAX index increased by 13.1% and the MSCI Europe index increased by 10.1% in US dollar term. Gains were seen in across sectors such as consumer discretionary, technology, energy, industrial, financial, and basic materials while utilities lagged.

European markets were bolstered by positive economic data and continued assurances of unwavering support from the European Central Bank (ECB). The ECB committed to purchasing 1.85 trillion euros (US\$2.2 trillion) of bonds until March 2022 as part of its Pandemic Emergency Purchase Program while policymakers voted for ongoing government stimulus.

The market was also supported by a strong corporate earnings season and an acceleration in vaccine roll-out to battle the COVID-19 pandemic. Many countries were able to loosen restrictions on social and economic activities which increased consumer and investor confidence.

Results of Operations

For the period ended June 30, 2021, the Fund decreased 0.6% for Series A units and 0.5% for Series F units, after fees and expenses, while the MSCI AC Europe Total Return Index increased 9.2% in Canadian dollars. In U.S. dollars, the Fund increased 2.0% for Series A units and 2.1% for Series F units, while the MSCI AC Europe Total Return Index increased 12.4%.

The largest decliners in the period were the equity holdings of Jet2 PLC, Rolls-Royce Holdings PLC and Cairo Mezz PLC. The increase in prices of Stellantis N.V., Abbey Public Limited Company, and Wizz Air Holdings PLC helped to offset some of the losses.

The euro depreciated against the Canadian currency during the period, which contributed negatively to the performance of the Fund.

Portfolio Update

During the period, the Fund initiated investments in Liberty Global PLC shares. The Fund also sold its holdings in Cpl Resources PLC.

The Fund did not enter into any forward currency contracts for pounds sterling or euros in the first half of 2021. The Fund also had no covered call options in its portfolio as at June 30, 2021.

During the first half of 2021, the Fund received \$656 in income from its securities lending program.

The Fund's net redemptions in the first half of 2021 were approximately \$336,622 for Series A units and approximately \$1,330,180 for Series F units. The Fund's average month-end cash position for the period was 21.3% of the Fund's net assets.

Recent Developments

The ongoing COVID-19 pandemic has continued to disrupt businesses around the world. Uneven vaccination rollouts and the emergence of new variants have added volatility to both domestic and international markets.

While governments and central banks have maintained their support of the economy through monetary and fiscal policies, the shape of the pandemic recovery remains unclear at this time.

Based on this increased uncertainty, we expect the performance of the Fund's portfolio to be affected to some degree in the near term.

Related Party Transactions

The Manager manages the overall business of the Fund, including selection of the securities in the Fund's portfolio, and promoting the sale of the Fund's units.

The Manager is also the trustee of the Fund. Investors receive units of a trust when they invest in the Fund. The Manager, as trustee, holds the actual title to the property in the Fund, the cash and portfolio securities, on behalf of the Fund's investors.

The Manager, its officers and directors invest in units of the Fund from time to time in the normal course of business. As of June 30, 2021, the Manager, its officers and directors hold 4.6% of the Series A units of the Fund. All transactions with the Manager are carried out at the Fund's net asset value as at the transaction date.

During the period ended June 30, 2021, there were no transactions with related parties except in the capacities and instances set out above.

⁽²⁾ Net assets and distributions are based on the actual number of redeemable units outstanding at the relevant time. The increase/decrease from operations is based on the weighted average number of redeemable units outstanding over the financial period.

⁽³⁾ Distributions were reinvested in additional units of the Fund or paid in cash upon request.

⁽⁴⁾ This information is provided as at the period end shown and is rounded to the nearest thousand.

⁽⁵⁾ Management expense ratio ("MER") is based on total expenses (excluding commissions and other portfolio transaction costs) for the stated period and is expressed as an annualized percentage of weekly average net asset value during the period. The Manager may, at its discretion, waive or absorb certain operating expenses. MER includes the waiver or absorption by the Manager of certain operating expenses, while the MER before absorption shows the MER prior to operating expenses being waived or absorbed by the Manager.

⁽⁶⁾ The trading expense ratio represents total commissions and other portfolio transaction costs expressed as an annualized percentage of weekly average net asset value during the period.

⁽⁷⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio adviser manages its portfolio investments. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of the securities in its portfolio once in the course of the financial period. The higher a fund's portfolio turnover rate in a year, the greater the trading costs payable by the fund in the year, and the greater the chance of an investor receiving taxable capital gains in the year. There is not necessarily a relationship between a high turnover rate and the performance of a fund.

Management Fees

The Manager manages the Fund. The Manager is entitled to an investment management fee calculated daily as a percentage of the market value of the net assets equal to 1.5% per annum for Series A units and 1.0% per annum for Series F units, payable monthly. The Manager pays 50 basis points per year trailer fees to dealers out of management fees for Series A units. There is no trailer fee paid out for Series F units.

Past Performance

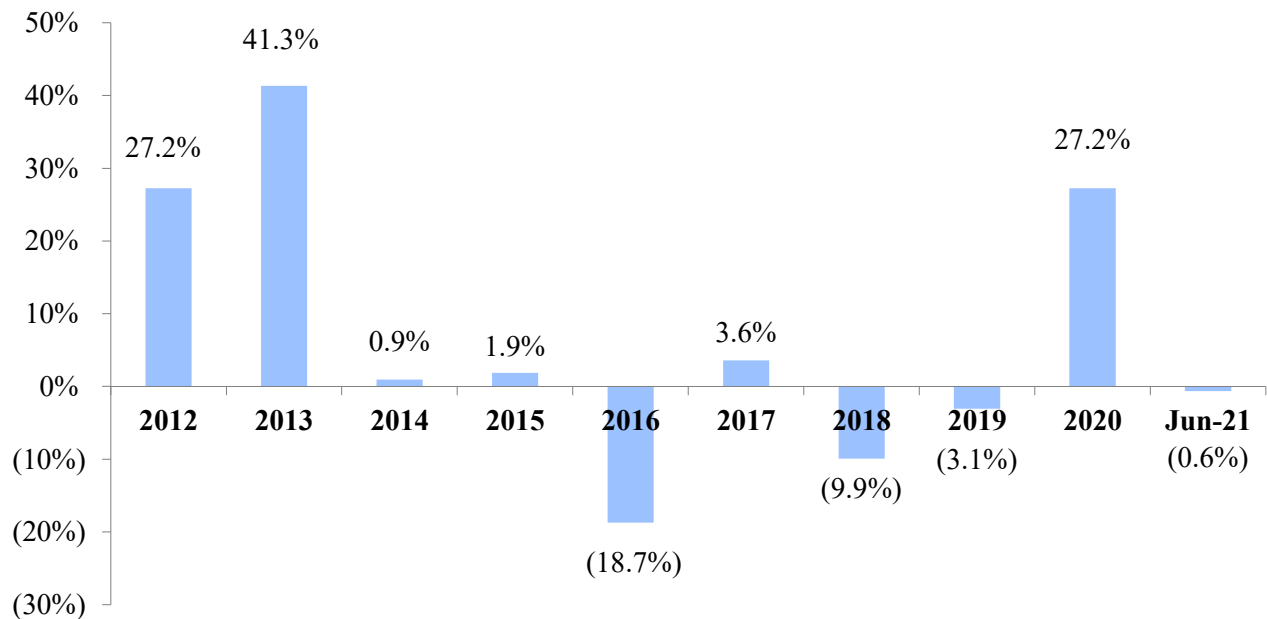
General

Year-by-Year Returns

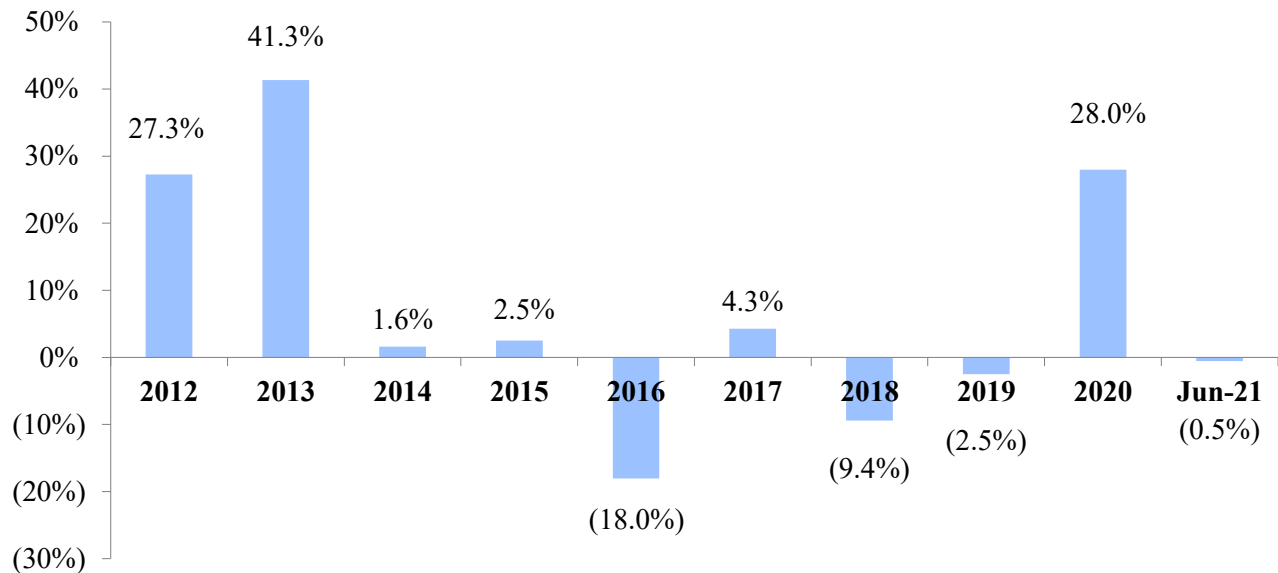
