What does the fund invest in?

The Chou Associates Fund's investment objective is to provide long-term growth of capital by investing primarily in equity securities of US and foreign businesses considered by the Manager to be undervalued. The fund may invest in the equity securities of Canadian businesses, and may include common and preferred shares, convertible debentures, warrants, government and corporate bonds and short-term indebtedness.

The charts below give you a snapshot of the fund's investments on August 31, 2024. The fund's investments will change.



How has the fund performed?

This section tells you how the Series A units of the fund have performed over the past 10 years. Returns are after expenses have been deducted. These expenses reduce the funds' returns.

Year-by-year returns

This chart shows how Series A units of the fund has performed in each of the past 10 completed calendar years. The fund dropped in value in 4 of the 10 years. The range of returns and change from year to year can help you assess how risky the fund has been in the past. It does not tell you how the fund will perform in the future.



Best and worst 3-month returns

This table shows the best and worst returns for Series A units of the fund in a 3-month period over the past 10 calendar years. The best and worst 3-month returns could be higher or lower in the future. Consider how much of a loss you could afford to take in a short period of time.

Average return

As of August 31, 2024, the annual compounded return of Series A units of the fund was 5.2% over the past 10 years. If you had invested \$1,000 in the fund 10 years ago, your investment would now be worth \$1,655.

How much does it cost?

The following tables show the fees and expenses you could pay to buy, own and sell Series A units of the fund. The fees and expenses - including any commissions - can vary among series of a fund and among funds. Higher commissions can influence representatives to recommend one investment over another. Ask about other funds and investments that may be suitable for you at a lower cost.

1. Sales charges

An initial sales charge may be payable by you when you purchase Series A units of the fund.

2. Fund expenses

You don't pay these expenses directly. They affect you because they reduce the fund's returns. As of June 30, 2024, the fund's expenses were 2,20% of its value. This equals \$22,00 for every \$1,000 invested.

More about the trailing commission

The trailing commission is an ongoing commission. It is paid for as long as you own the fund. It is for the services and advice that your representative and their firm provide to you.

Chou Associates Management Inc. pays the trailing commission to your representative's firm. It is paid from the fund's management fee and is based on the value of your investment. The rate is 0.5% of the value of your investment each year. This equals \$5.00 each year for every \$1,000 invested. As of June 1, 2022, Chou Associates Management Inc. ceased paying a trailing commission in respect of your Series A units held with a discount broker or dealer that may not have completed a suitability analysis.

3. Other fees

You may have to pay other fees when you buy, hold, sell or switch units of the fund.
